

Subscription Policy

Subscription Payments & Holding Your Child's Place — **VERY IMPORTANT**

- ♦ PAYG is for your first month only — monthly fees follow
- ♦ Payments are due on the **1st of every month. After** the initial **PAYG period**
- ♦ You must pay every month to hold your child's place, even if your child is away.

Our monthly fee is calculated by:

- Total weeks venue operates annually ÷ 12 months
- Your payment stays the same every month, covering weeks with more sessions and scheduled closures (e.g., Summer, Christmas).

⚠ Do NOT cancel your standing order!

This ensures payments arrive on time and your child's place remains secure.

Payment Terms:

If payment is not received by the due date:

- The cash rate will apply for that month (see cash rate prices).

If payment is late by more than 7 days:

- A £10 late payment fee will be added.

The Only Exceptions:

- If the **1st** falls on a **Sunday or bank holiday**, payment must be received by the next working day.
- Incorrect payment amounts may also cause late fees due to extra admin, please check your standing order is correct and set for the 1st (or next working day if needed).

Important:

- ✗ No payment = No attendance, your child can not attend until subs are paid
- ✗ If payment is missed, and we do not receive any correspondence from you via phone call or email your child's place will be released to someone on the waiting list.
- ✗ If you go on holiday and cancel your standing order your child's place will be lost only paying places will keep their spot

Subscription Policy

To Avoid Delays

- **Check your standing orders** to ensure they are set up for the correct amount and scheduled for the **1st of each month**. When the 1st falls on a Sunday or bank holiday, standing orders will automatically process on the following working day.
- **Ensure the correct payment amount is set up**. Going forward, late charges will apply if incorrect amounts are paid and require additional follow-up from the admin team.
- **No attendance if not paid**. If you have not paid your child will be unable to attend until payment has been made.

Venue Operating Weeks:

- Grimsby: 50 weeks per year
- Preston: 48 weeks per year
- Barton: 47 weeks per year

Sibling Discount

We offer a **4% sibling discount** for families with more than one child training with us. This discount applies to each child's fees while multiple siblings are enrolled.

If a sibling stops training, the discount will no longer apply, and the remaining child's fees will return to the standard member rate.

This discount **does not apply to PAYG** sessions and only takes effect when the standing order starts.

Notice Period for Leaving

Our terms and conditions require a minimum of **30 days' written notice** if you wish to leave the club.

- Notice must be given in writing. Once notice has been received, the admin team will confirm your child's final session date and any remaining balance due for the 30-day notice period.
- Your child may continue attending their usual sessions until the final session date confirmed by the admin team.
- Standing orders are controlled by parents and must be cancelled directly with your bank once notice has been given. We are unable to cancel a standing order on your behalf.

Subscription Policy Continued

- Please allow 2-3 working days for the admin team to calculate and confirm your child's final session date and any remaining balance due. **If your standing order has already been cancelled, the remaining balance for the 30-day notice period must be paid by**
- Cancelling your standing order **does not remove the requirement to pay for the full 30-day notice period.** Any outstanding notice-period balance remains payable in line with the membership terms agreed to when joining.
- We do not provide refunds. Any payments received after the confirmed notice period cannot be reimbursed, so please ensure your standing order is cancelled once your final balance has been confirmed and paid

Terms & Conditions

Our Terms & Conditions outline the rules, policies, payment obligations, and membership requirements of Twist & Flip Gymnastics.

By ticking the agreement checkbox during registration, you confirm that you have read, understood, and accepted these Terms & Conditions. This forms a legally binding agreement between you and Twist & Flip Gymnastics.

This includes agreement to:

- the club's payment and subscription terms
- standing order payment arrangements
- the mandatory 30-day written notice period for cancellations
- payment of all fees due during the notice period, whether or not your child attends the remaining sessions

Cancelling a standing order, or choosing not to attend sessions, does not automatically end the membership agreement. Any fees due during the agreed notice period remain payable in line with these Terms & Conditions.
